

## **Management Committee Members and Biographies**

### **Tom Brown CPFA (Chairperson)**

Tom is the current Chairperson having been elected to that position in 2015 following a 16 year period as Treasurer.

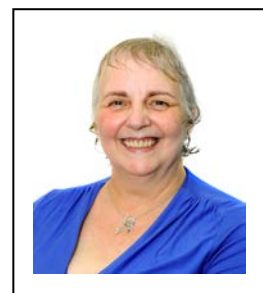
Lynne currently serves on the Health, Safety & Human Resources Committee.
